## 1 General

## 2 Limitation of liability -International

Airbest Express Cargo's liability is limited to \$100, or the shipment's declared value, whichever is lower, unless the sender purchased insurance by paying an additional fee

## 3 Limitation of liability -personal cargo to India

Upon delivery, please inspect the parcel while the courier waits. If unable, mark unchecked" on the Proof of Delivery (POD). Report and note any damage or missing items on the POD with details and take photos as proof. Your signature is required, and you'll receive a POD copy. Claims must be made within 48 hours of delivery. Eligible claims are compensated for up to AED 20 per kg

## 4 Inspection

Airbest may open and inspect any shipment at any time without notice for safety, security, customs, or regulatory reasons, and bears no liability for doing so.

## 5 Prohibited goods
